(5) The County will grant administrative leave hours on Good Friday, the day after Thanksgiving and Christmas Eve (or specified date if Christmas Eve falls on a Saturday or Sunday) when and if the State also grants administrative leave hours during those periods to state employees. Employees required to work those periods would be granted administrative leave (in the equivalent amount) to be used at a future date.
