

**RESOLUTION #15-05**  
**A RESOLUTION AMENDING THE OFFICIAL PAY PLAN FOR 2015**


WHEREAS, Resolution #15-01 was approved by the Brookings County Board of County Commissioners on January 6, 2015.

WHEREAS, an additional Truck Driver position, .5 FTE with the Highway Department and .5 FTE with the Weed Department, was approved as part of the 2015 Budget, but not included in the Official Pay Plan for 2015 approved in Resolution #15-01.

THEREFORE, BE IT RESOLVED by the governing body of Brookings County, South Dakota:

That the Official Pay Series and Management Salary Compensation be amended to include a Truck Driver position, .5 FTE with the Highway Department and .5 FTE with the Weed Department, and that the Official Pay Series and Management Salary Compensation increase accordingly to reflect said position, as indicated in the attachments hereto, and the same will be administered for the year 2015 to become effective January 1, 2015.
