A Resolution Approving Uncollectable Mobile Homes
To be Placed on the Uncollectable List

WHEREAS South Dakota Codified Law (SDCL) 10-22-30 requires the County Finance Officer present a list of all distress warrants returned by the Sheriff as uncollectable to the Board of County Commissioners. The Board has examined such returns and is satisfied with reports from the Sheriff and Finance Officer that the taxes described in any such warrant cannot be collected.

NOW THEREFORE, BE IT RESOLVED by the Brookings County Board of County Commissioners, at their regular meeting on July 2, 2024, that they have directed the County Finance Officer to put uncollectable mobile homes on the uncollectable list until it is determined either by the Board of County Commissioners or the County Finance Officer that such taxes have become or may have become collectable. There will be a complete listing of all uncollectable mobile homes and buildings on leased sites on file in the Brookings County Finance Office.
