Territories by the City of Volga


WHEREAS the City of Volga desires to annex the following described properties, to wit:

The North Seven Hundred Twenty Feet (N 720') of the West Four Hundred Twenty Feet (W 420') of the West One-Half of the West One-Half of the Southeast Quarter (W ½ W ½ SE ¼) of Section Twenty-Three (23), Township One Hundred Ten (110) North, Range Fifty-One (51) West of the 5th P.M., County of Brookings, State of South Dakota, EXCEPT the North Two (2) Rods Thereof and EXCEPT Lots Six (6) and Seven (7) in Block One (1) of Bertelsen's Golf Course Addition in the West One-Half of the Northwest Quarter of the Southeast Quarter (W ½ NW ¼ SE ¼) of Section Twenty-Three (23), Township One Hundred Ten (110) North, Range Fifty-One (51) West of the 5th P.M., County of Brookings, State of South Dakota, and

WHEREAS pursuant to SDCL 9-4-5, such annexation is subject to review by the Board of County Commissioners.

THEREFORE, BE IT RESOLVED by the Brookings County Board of County Commissioners, that the annexation of the above-described territories by the City of Volga be and the same is hereby approved.

RESOLUTION #2024-50

A RESOLUTION OF ANNEXATION OF CONTIGUOUS TERRITORY TO THE CITY OF VOLGA, SOUTH DAKOTA.

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF VOLGA, SOUTH DAKOTA, AS FOLLOWS:

WHEREAS, the City of Volga, South Dakota is authorized pursuant to South Dakota Codified Law §9-4-1 to annex contiguous territory upon receipt of a written Petition signed by not less than three-fourths of the registered voters residing within territory sought to be annexed and by the owners of not less than three-fourths (3/4) of the value of the territory sought to be annexed, and which describes the boundaries of territory contiguous to the municipality; and

WHEREAS, the property proposed to be annexed is contiguous to the present boundaries of the City of Volga, and

WHEREAS, the Petition for Annexation has been signed by the owner of not less than three-fourths (3/4) of the value of the territory sought to be annexed; and

WHEREAS, there are no registered voters residing in the territory sought to be annexed; and

WHEREAS, the City of Volga has determined that the statutory requirements for annexation of the following described property have been satisfied; and

WHEREAS, the governing body of the City of Volga has determined, subject to the following conditions, that the following described property is suitable for annexation to the City of Volga:


The North Seven Hundred Twenty Feet (N 720') of the West Four Hundred Twenty Feet (W 420') of the West One-half of the West One-half of the Southeast Quarter (W $\frac{1}{2}$ W $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Twenty-three (23), Township One Hundred Ten (110) North, Range Fifty-one (51) West of the 5th P.M., County of Brookings, State of South Dakota, EXCEPT the North Two (2) Rods thereof and EXCEPT Lots Six (6) and Seven (7) in Block One (1) of Bertelsen's Golf Course Addition in the West One-half of the Northwest Quarter of the Southeast Quarter (W $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-three (23), Township One Hundred Ten (110) North, Range Fifty-one (51) West of the 5th P.M., County of Brookings, State of South Dakota, and

WHEREAS, the owner of the property which is the subject of this Annexation Resolution has executed an Annexation Agreement which provides the conditions under which the above-described property may be annexed.

NOW THEREFORE, BE IT RESOLVED by the City of Volga, South Dakota, that the property described above is hereby annexed to the City of Volga, South Dakota.


